Neighborhood Watch Update

I hope you have been enjoying your summer so far. More than 40 days of over 90° and many more to go, and the earth shakes a little for us too, a reminder that we share this world with many a stronger force.

Our neighborhood watch program has been underway now for several months, and I can report that we have made progress in monitoring our community. We have had an influx of volunteers who have either decided to become block captains [thank you!] or those that would rather just be an extra pair of eyes. We are moving on to the next step, the more active part of our Watch, after the RCA clears up a few legal hurdles, i.e. having all volunteers sign a waiver form, providing proof of insurance, and receiving proper training. We are also in contact with the Montgomery County police, to apprise them and to keep them up to date on our progress. Additionally, we have ordered a

magnetic vehicle sign for our patrols, as well as window stickers for our fellow neighbors to place on their homes. They will be distributed by our block captains, and will also be available at our next RCA meeting in September.

The active part of patrol will comprise of at least two volunteers that will patrol the neighborhood, either by car, foot, bike, motorcycle, horse, or boat [just kidding!] for a couple hours at a time. I will put our new volunteers in touch with our scheduler, Ms. Mara Greengrass, once you have been properly trained. Keep in mind the more volunteers we can recruit, the more often we could develop regular patrols in RCA-Land.

A reminder to all: if you see anything that is suspicious in your area, please, please call the police department's non-emergency number at 301-279-8000 (or 911 if it is life-threatening). I am still looking for more volunteers; we need both block captains and regular assistants to keep eyes out on your street.

Randolph Civic Association to Host Final District One Debate

On September 2nd at 7:30pm the RCA will host the final District One Council debate before the primaries. The primaries will be held on September 14th. This important event will showcase the two Democratic primary candidates, Roger Berliner and Ilaya Hopkins, and allow our residents to make an informed decision



at the polls. The event will take place at the Viers Mill Recreation Center at the corner of Beach Drive and Garrett Park Road.

Questions will be asked by a three-person panel. The panel will consist of Barnaby Zall (Friends of White Flint and Citizens League of Montgomery County), Marc Korman (Western Montgomery County Citizens Advisory Board), and Chad

Salganik (RCA VP and Citizens League of Montgomery County). The audience will be able to personally ask questions in addition to submitting question cards, which will be given to the panelists. The candidates will each have one minute to respond and will be allowed one rebuttal for each question.

At this critical time in our County, it is more important than ever to make an informed decision at the poll. Some of the topics are sure to be the County budget, schools, economic vitality and the White Flint Sector plan. Please email dan@randolphcivic.org if you would like to volunteer at the event.

- **Thanks to Boy Scout Eric Uglen, four of our neighborhood signs received a much needed facelift this summer.** To fulfill his Eagle community service project, Eric Uglen led a group of volunteers who scraped and painted the signs and added new plantings and mulch. Thanks Eric, the signs look great! On another front, the RCA is working with sign companies to come up with a new concept for future neighborhood signs. At some point in the coming year, we will present design options to the community. It is our hope to raise enough money to eventually replace the current signs, and maybe add some new ones.
- **After two years of work by RCA volunteers, including countless meetings, phone calls, and e-mails, the long awaited picnic shelter is on its way for Randolph Hills Local Park.** At the June RCA meeting, President Dan Hoffman appointed a committee to study the proposed designs put forward by Park staff. Construction of the octagonal shelter (see photo), with features including picnic benches, barbecue grill, decorative landscaping, and a sitting wall, is planned for Spring 2011. However, according to Park staff, the project may happen sooner. Look for more details in the September Echo.

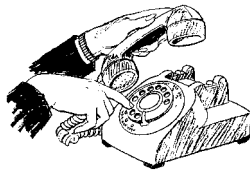

Randolph Civic Association June Meeting Minutes

Call to order at 8:10 p.m.

This was our last monthly meeting before our customary summer break. We will resume regular monthly meetings again on September 2, 2010. After welcoming the 30+ Randolph Hills residents who came out to our meeting, Dan Hoffman gave the floor to our guest speaker State Delegate Al Carr, who complimented RCA as being "the best civic association in our county." Thank you, Al. He gave a quick summary of the past legislative session, where in the short span of 90 days 2700 bills were introduced, and of them 810 bills and four resolutions were passed. Additionally, the State's budget had to be balanced and passed (which is a Maryland state constitutional requirement). Al serves on the Environmental Matters Committee, which covers environmental concerns, transportation, traffic, local governance, and ethics. The Committee is involved in Chesapeake Bay related water issues, pollution control and rainwater runoff control, including agricultural runoff. One can obtain more detailed information directly from his office. Residents can contact Al Carr's office and ask for help regarding constituents' services, county issues, and possible scholarship monies.

Some highlights from this year's legislative session:

- Carr's office participated in getting solar energy legislation implemented. His staff is helpful in assisting residents with their options on installing solar panels, and in getting hooked up to the grid which enables them to actually "sell back" unused generated energy to PEPCO.

- The legislature was also instrumental in passing a Green Buildings Law. Environmentally friendly building standards are now mandated for public buildings, and Community College buildings.

- This year's legislature also passed the ban on texting while driving, as well as no talking on a handheld cellphone while driving, both are enforceable as secondary offenses.

- Plastic baby bottles and other food-related plastic products must now be BPA-free (see the May Echo).

Special Discussion: Public Safety in RCA Neighborhoods

Dave Matera, our Public Safety Committee chair, and himself a police officer, working in Virginia introduced the main agenda point of today's meeting. The County's Public Safety budget is being cut 8-10%. (By comparison, our county libraries budgets have taken a hit of 24%.) Police officer positions have not been reduced, but there was no new police academy class recruited for July, for budget reasons. We have about 1.2 police officers assigned for every 1,000 residents,

which puts us well below the national average of 2.5 officers for every 1,000 residents.

There is discussion whether the independent Parks Police should be folded into the County Police Department (maybe as a special Division). There are some logistic pitfalls, where jurisdiction of one or the other department ends, or whether isolated pocket parks could be patrolled more effectively by County Police. The two departments combined might be able to operate more efficiently. Also, the Community Officers positions might be reassigned to other police duties. Councilman Elrich is in support such a merge. As we have some reoccurring issues with tent encampments (by the railroad tracks, or over by Parklawn), RCA has an interest in how policing and support services of these public green spaces are being handled between the two police agencies.

Overall, violent crimes keep dropping in numbers, while thefts from vehicles keep going up. In the RCA neighborhood, there were 27 incidents reported in May, mainly larceny and theft from vehicles (unlocked cars or windows being pried open), home burglaries, and burglaries at commercial properties. Two assaults were reported on Wyaconda & Creek Shore, and on Schuylkill, no further details. Overall, Matera reported, we have no specific concentration of criminal activity in Randolph Hills. There has also been no increase in reported gang activity, if at all, then on the other side of Dewey, towards Veirs Mill Road. The County Council receives quarterly crime reports, but these numbers are county-wide, not specific by neighborhood. One can also check on locations of reported crimes on the website www.CrimeReports.com

RCA Neighborhood Watch: With the recent uptick in crime reports on the RCA listserve, there has been renewed interest in getting our Neighborhood Watch active again. We have currently 19 block captains and volunteers, but we need more participation (on all levels of involvement) to be effective. Although Randolph Hills is a well-established neighborhood, we've had lots of turnover, people moving in and out and not getting to know their neighbors. Here are some basic practices that every resident can apply, just to contribute to overall safety and neighborliness:

- introduce yourself to new (and old) neighbors
- keep an eye out; if in doubt, call the police, and put these numbers into your cell phone now: Park Police non-emergency: (301) 949-8010; If action is not park-related, County Police Non-emergency number: (301) 279-8000.
- report groups of people walking about late at night, who might be probing car doors
- keep your bushes trimmed and your grass cut to not let your property look abandoned, or to provide an easy hiding place
- upgrade your outdoor lighting, motion lights, security cameras
- lock your utility shed, lock your ladder, lock your storm/screen doors
- When you buy electronics, do register them with the company, write down the serial number in your manual. Today's re-sell venue is not so much the pawn shop, rather

E-Bay.

- Don't let newspapers and flyers accumulate on your doorstep, suspend your subscriptions.

Some meeting participants complained about the many circulars that are being left on the walkways and doorsteps. Some find "The Examiner" (twice a week), or the "Gazette" (once a week) a nuisance. The plastic sleeve of the Examiner actually bears a phone number one can call to stop delivery.

David Matera disseminated various safety flyers (which are being posted on the RCA website), including "What is a Neighborhood Watch?" He mentioned some incidents in high-crime areas in Connecticut, how some criminal "businesses" went about staking out their targets in startlingly professional manner, having "spotters" on the street who noted down ("on an Excel spreadsheet") when residents were coming and going for work, etc.

Dan Hoffman asked the assembled participants, what could be useful for You, having a Neighborhood Watch? Some responses: Having more "RCA Neighborhood Watch" signs posted.

Now about the Nuts and Bolts of Organizing our Neighborhood Watch:

- we have more block captains signed up (ongoing)
- make a schedule
- schedule training, work with the police
- co-ordinate patrols
- dog walkers make ideal participants, as they're often out at regular hours
- have active (patrol) and passive (eyes-and-ears) involvement possibilities
- make our organized watch public and visible. Everybody should know.
- Post "Neighborhood Watch" signs and yard signs
- Make window stickers, and post the decal on the RCA website
- Determine when our patrols will be most effective, and workable (day and night hours)
- Bi-lingual and foreign-language outreach to our international neighbors
- Environmental policing: report burned-out street lights (each light pole has a number, and you can dial 311 to report the burned out street light with pole number). Wooden light poles are PEPCO, metal poles are the County's).

What does a Block Captain do?

- lets neighbors on the street know about the effort, to increase awareness and participation
- recruits more neighbors
- makes a list of participants: address, phone, email
- hosts a meeting

- organizes an engraving initiative where neighbors can get their electronics engraved with ID
- there can be more than one block captain on one street, it just means assigning a workable group of homes (10 – 20 homes) to each captain.

Old Business:

Voter Guide: Following the RCA meeting last November, RCA has developed a Voter Guide that will list our County politicians' votes and actions on schools, safety, and revitalization issues. They can also list specific accomplishments, their goals, and their engagement with us constituents. This voter guide will go out to our elected officials shortly. Dan Hoffman made a call for volunteers to analyze and compile the responses. We will present these data in our September Echo, just in time for the September 14 Primaries. One meeting participant commented that we should include, under "quality of our parks", specifically our Rock Creek Park safety. Another participant was impressed by our rubric "engagement", pointing out the importance of this aspect of our public discourse. **RESOLVED UNANIMOUSLY TO ACCEPT THE VOTER GUIDE QUESTIONS, WITH THE SUGGESTED EDITS.**

Farmers Market: Christiana Drapkin has done some legwork on finding out about starting a farmers market in RCA-land. Unfortunately, the property managers of the site at the 4701 Randolph Road Health Center, are not welcoming the idea. However, there are other sites for us to look at and analyze. And we want to be in a
